

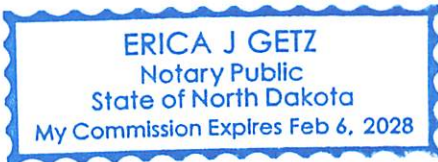

**Section 32, Twp 134N, R 92W, Hettinger County, North Dakota.**


Montana-Dakota Utilities Co. has made a prima facie showing that it should serve the customer.


