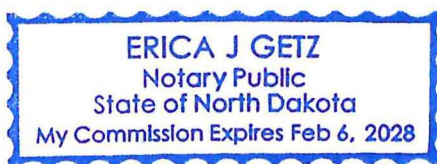

On May 28, 2024, Otter Tail Power Company, an electric public utility, filed an application under North Dakota Century Code Chapter 49-03 to extend service to Dwight Grotberg at a location in Barnes County, North Dakota.
