**AMENDMENT NO. 3
TO THE INTERCONNECTION/AGREEMENT
BY AND BETWEEN
CONSOLIDATED TELCOM AND MIDCONTINENT COMMUNICATIONS**

This Amendment (“Amendment No. 3”) amends the Interconnection Agreement by and between Consolidated Telcom “ILEC”) with offices at 507 South Main, Dickinson, ND 58601 and Midcontinent Communications (“CLEC”) with offices at 101 S Reid St STE 202, Sioux Falls, SD 57103 and shall be deemed effective upon approval by the Commission (“Effective Date”). This agreement may refer to either company as a “Party” or collectively as the “Parties”).

RECITALS

WHEREAS ILEC and CLEC are parties to an Interconnection Agreement under Sections 251 and 252 of the Communications Act of 1934, as amended (the “Act”), dated January 25, 2008, and October 20th, 2013; and

WHEREAS, the Parties have subsequently agreed to amend the Agreement in order to update Section 3 of the Interconnection Attachment of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

AMENDMENT TERMS

1. Physical Network Connection.

The Parties agree to physically connect their respective networks via an IP connection at the Consolidated – Dickinson (DCSNNDASDS0) end office. The terms of the IP connection are negotiated outside of this agreement. The terms of the IP connection detail the physical exchange of Local Traffic between MidContinent End User Customers and the Consolidated End User Customers in the Consolidated service area.

3. The provisions of this Amendment No. 3, including the provisions of this sentence, may not be amended, modified or supplemented without the written consent thereto by both Parties' authorized representatives.
4. Except as expressly set forth herein, the terms and conditions of the Original Agreement shall remain in full force and effect without change.
