[1.] Coyote Creek Mining Company, L.L.C. (“CCMC”), whose address is 6502 17<sup>th</sup> St. SW,  
Zap, ND 58501 and telephone number is 701-873-7800, and who is represented by the  
undersigned, hereby provides notice that Casey Voigt and Julie Voigt (the “Voigts”), whose  
address is PO Box 454, Beulah, ND 58523 and telephone number is 701-873-2211, are in violation  
of the Public Service Commission’s Order On Attorney’s Fees dated May 8, 2025 (the “Order”).  
That Order awarded CCMC \$21,517.50 in attorney’s fees against the Voigts. Despite the passage  
of time and service of a demand dated February 3, 2026, the Voigts have not paid any of that  
amount to CCMC. CCMC serves this notice as a prerequisite to a citizen’s suit under N.D.C.C.  
§ 38-14.1-40 to enforce the Commission’s Order and collect the referenced award.
