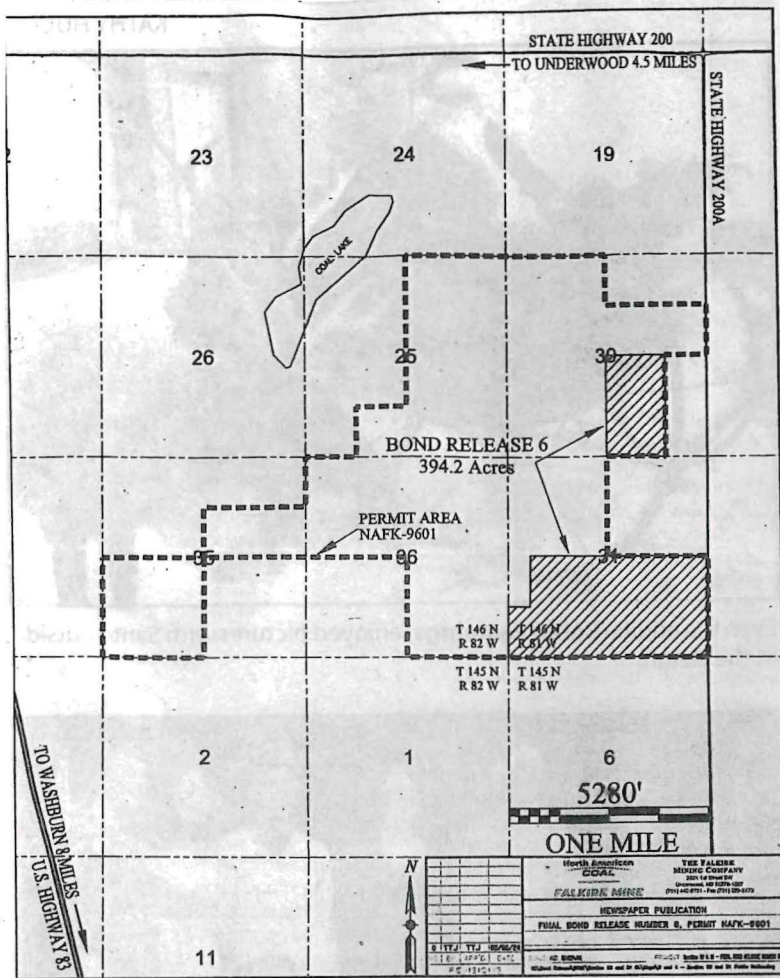

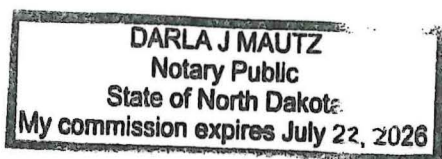

Notice Of Filing For Final Release Of Reclamation Bond

The Falkirk Mining Company, 2801 1st Street S.W., P.O. Box 1087, Underwood, North Dakota, 58576, as applicant, has this 25th day of September, 2024 filed for final bond release for completion of reclamation work on the following tract of land. Bond Release Number 6 to Permit NAFK-9601 consists of 394.2 acres of land in Section 30 and Section 31, T146N, R81W, of McLean County (see attached map).

Bond Release Number 6 is located in Falkirk's approved state mining Permit NAFK-9601. The North Dakota Public Service Commission approved Permit NAFK-9601 on August 28, 1996. The worst case bond determination for Permit NAFK-9601 is not incremental and is covered by a collateral bond. The current bond coverage for Permit NAFK-9601 is \$2,831,808.00. As part of this final bond release application, Falkirk is requesting a bond reduction of \$353,998.73. Falkirk is requesting bond release stages I-IV for the completion of all surface coal mining and reclamation operations on 1.5 acres, and stages III-IV for vegetation establishment and demonstration of revegetation success on 275.4 acres, the remaining 117.3 acres are undisturbed. Mining and/or mining disturbance was initiated in 1996 and completed in 2006. Coal was removed in 1996 to 2003. Approximately 70% of the area was disturbed by mining

or associated disturbances (haul roads, stockpiles, ponds, and diversions). Final grading to post-mining contour was completed in 2006. SPGM respread and initial seeding was completed in 2001, 2002, 2003, 2006, and 2007. The approved post-mining land use is cropland, one seasonal wetland, four temporary wetlands, and a portion of a section line. Reclamation was completed according to the requirements in the approved reclamation plan.

Written comments, objections, or requests for a public hearing or informal conference regarding this final bond release request may be submitted by any person with an interest which is or may be affected by release of the bond to the North Dakota Public Service Commission, Capitol Building, 600 East Boulevard Avenue, Bismarck, North Dakota, 58505, within 30 days after the last publication of this notice. Any request for an informal conference or hearing should be made in writing to the Commission and the request should include the issues or objections that an affected party has regarding this bond release.
