his is in response to the letter dated August 14, 2025 for the cleaning of the ditch or swale in front of my home at 12548 24th street NW watford city North dakota. Facts, in my opinion, are as follows:

Before I started the cleaning of the sediment in the swale/ditch i went to the county and spoke with them about it and they told me that it was ok to clean the sediment out of the ditch which i had to do because my drive way was washing out due to the oil and gas company tearing up my drive way. You will see that the drive way never was stable again and was causing a safety hazard. In fact, the kids school bus company said they no longer could pick the kids up because it was not safe for the bus to come up the drive way. I have attached the pond that was at the bottom due to all the sediment clogging the pipe the county came out a half a dozen times to repair the road in front. Even installed a pipe in the road to carry the water to the other side of the road. I cleaned out the sediment out of the ditch or swale to the original grade which the county does as maintenance. The day of the incident a kinder morgan employee was out there when the guys were cleaning the dirt out back to the original grade. I drove down my drive way got out of my car and walked over to them and the very first thing the kinder morgan employee said was WHAT THE !!!! ARE YOU DOING CHRIS!!!! I am the land owner and the level of respect kinder morgan shows land owner is clear its zero. I told him to get off my property that he was not allowed on it and told me this is his right away and he has a pipeline under the drive way and i had poured concrete on top of the exiting grade to make it a safe entrance for my family and mail service. He told me that he promised that the concrete I poured would be removed and its not aloud to be there because i did not ask permission from kinder morgan. Again, I told him to get off my property i then called kinder morgan 6 times over the next two weeks with not a single returned call. I also went back to the county and told them what happened and they told me if i was not excavating that it was just maintenance and not to worry about it and also said if they removed the concrete they would have an issue with that as well.
