

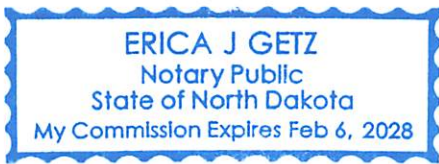


The issue to be considered in this proceeding is whether the Commission should grant deferred accounting treatment for the costs of the settlement agreement with the PIIC.

Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by February 13, 2025.** If deemed appropriate, the Commission can determine the matter without a formal hearing.
