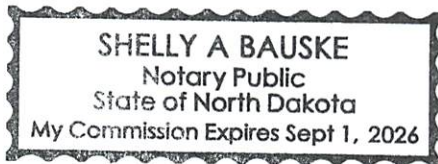


Montana-Dakota Utilities Co. has made a prima facie showing that it should serve the customer.


