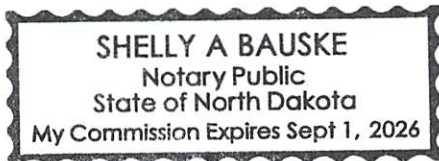

NOTICE OF OPPORTUNITY FOR HEARING

On January 31, 2025, Otter Tail Power Company (OTP) filed a request for approval of 2025 rates for small power production, cogeneration, and the renewable energy credit rider in addition to modifications to the tariff.

The issues to be considered in this proceeding are:

1. Are the proposed tariff revisions just and reasonable?
2. Do the proposed rates comply with the tariff?
3. Are the proposed rates just and reasonable?

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by April 7, 2025.** If deemed appropriate, the Commission can determine the matter without a formal hearing.
