

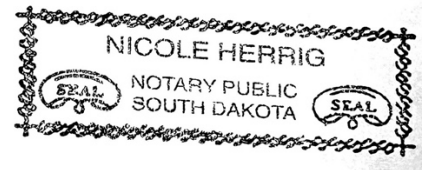

# Friends: Suspect long hated Mormons

GRAND BLANC TOWNSHIP, Mich. — The man who killed four people in a Michigan church while setting it ablaze long harbored hatred toward the Church of Jesus Christ of Latter-day Saints, according to long-time friends, and told a stranger who showed up at his door days before the attack that Mormons were the “antichrist.”

The suspect, identified as Thomas Jacob Sanford, 40, began making those sentiments known years ago after his return from Utah, where he dated but broke up with a girlfriend who was a member of the Mormon faith, two childhood friends said Tuesday. Sanford moved to Utah after leaving the Marines and told his friends he became addicted to methamphetamine.

No longer the happy-go-lucky kid who was voted class clown, Sanford routinely spouted off about his grievances against the church, his friends said. The first time they heard it was at a wedding 13 years ago.

“We were like, ‘come on,’ we don’t want to hear this,” said Bobby Kalush, who grew up down the road from Sanford. “When he came back from Utah, he was a completely different person.”

Just six days before Sunday’s attack, those grudges were still boiling, said Kris Johns, a city council candidate who described a bizarre brush with Sanford while door knocking for his campaign.

The two spoke at Sanford’s home in Burton about gun rights when Sanford physically leaned in, Johns said, and asked, “What do you know about Mor-

mons?”

For close to 15 minutes, Sanford spoke in controlled and calm tones about the Mormon faith, saying he was concerned about their beliefs while expressing that he was a Christian. Sanford then said he believed that Mormons are the “antichrist,” according to Johns.

“That’s something I’ll never forget,” he said.

Sanford drove his truck into the church’s brick wall while members were gathered inside Sunday morning. He apparently used gas to start the fire and also had explosive devices, said James Dier of the Bureau of Alcohol, Tobacco, Firearms and Explosives.

Police released very few details about Sanford, who died after being shot by officers, and refused to discuss what might have motivated the attack in Grand Blanc Township, about 60 miles north of Detroit.

On Tuesday, Sanford’s family released a statement through a lawyer, expressing condolences. “No words can adequately convey our sorrow for the victims and their families,” they said.

Sanford served four

years in the Marine Corps after enlisting in 2004 and deployed once to Iraq for seven months, according to military records. His commander during the deployment, David Hochheimer, said the unit never saw combat or incoming fire. “It was a relatively quiet time,” he said Tuesday.

Sanford moved to Utah shortly after leaving the military. His friends said they noticed a change after he moved back home, thinking his battle with addiction was to blame.

Kalush said his friend was no longer the “short, stocky ball of energy” who once bought dozens of flowers to give out to girls before the homecoming dance.

It wasn’t unusual for Sanford to start talking about how Mormons were going to take over, said Frances Tersigni, who along with his twin brother was among Sanford’s best friends.

“It was just so random. It was like, ‘Why Mormons dude?’” Tersigni said. “It’s hard to explain. We didn’t take it serious.”

Still, there were no signs that he was a threat to anyone, Tersigni said. An avid hunter, Sanford married

and was raising a child.

“He never once, never, said ‘I’ve got to do something,’” he said. “There’s a Jake we all knew, and there was one who was hidden. It wasn’t apparent to us.”

Federal investigators remained at the church Tuesday as heavy machinery began moving debris from the church.

Authorities have not yet released the names of the four people who died or the eight people — ages 6 to 78 — who were wounded and expected to survive. Among the wounded were a father and his young son, according to a GoFundMe post.

One of those who died was remembered as a grandfather who adored spending time with his family. John Bond, a Navy veteran, was well-known in the community and loved golfing and trains, according to friends organizing fundraising for the family.

Another victim was identified by family and friends as Pat Howard, 77, of Holly, Michigan. He attended the service with his wife, Kitty, who was not wounded during the attack, family friend Cara Carrubba said.

“Uncle Pat was so many things. ... In my mind I see him mid conversation, his eyebrows raised, his eyes bright and a smile just starting to show,” niece Maureen Seliger said on Facebook.

Jeffrey Schaub, bishop of the Grand Blanc church, said in a video posted Monday that the attack left the community reeling.

“As you can expect our members are quite shaken in spirit and in body,” he said. “And it hurts.” There was an outpouring of support from different faith communities, he said.

Jerry Eaton, 78, who lives across the street, sheltered seven people who fled the church, including a mother

with her four young children. He was watching television when he heard the shooting.

“I’ve done a lot of hunt-

ing, so I know the sound of gunfire,” he said. “As much as I didn’t want to believe it, that’s exactly what it sounded like.”

# Alaskans will receive \$1K checks

JUNEAU, Alaska — The truck that arrived ahead of schedule at Allyssa Canoy’s home in Fairbanks brought enough heating fuel for the frigid winter months ahead — and a surprise bill for \$2,600.

Canoy and her two sons have checks arriving that will cover that expense and leave some money for the boys, too. Starting Thursday, Alaska will begin distributing to residents their annual dividend derived from the state’s \$83 billion oil wealth fund, a sort of bonus Alaskans get for living in the state.

For some, it’s extra spending money for a new set of tires or a vacation to a sunnier clime during the long, dark winter. For others, it’s a vital supplement in a state where the cost for internet service, gas and groceries can be sky-high. This year, Alaskans will get \$1,000 per person — the lowest amount since 2020, when they each received \$992. The payout has been below \$1,000 only two other times since 2006.

There used to be a formula for calculating the amount that was tied to the fund’s market performance, but lawmakers widely consider that formula unaffordable and within the last decade abandoned it.

Politicians now set the amount. It’s often one of the last items settled during sensitive budget negotiations. Lawmakers must weigh the check’s size against other programs and public needs, including education, and in 2018 began using earnings from the fund — long used to pay dividends — to also help balance the budget.

This year, \$1,000 is

what lawmakers argued they could afford while also backing an increase in K-12 education funding and trying to limit draws from savings.

Had the old formula been followed, residents would get about \$3,800 each.

Voters created the fund in 1976, during the heady, early years of oil in the state. The goal was to save some of Alaska’s mineral wealth. The fund grew through investments, and while the state constitution protects the fund’s principal, its earnings can be spent.

Dividends were paid since 1982. Proponents saw them as a way to ensure Alaskans maintained a vested interest in the Alaska Permanent Fund.

More than 600,000 of Alaska’s roughly 740,000 residents are set to receive this year’s check. To qualify, one must meet residency and other requirements.

Three times, including last year, Alaskans received an energy relief payment along with their dividends, according to the state.

For some Alaskans, the check is a nice extra. Some put it into college funds or savings accounts or donate to charities.

Others rely on it for necessities, such as heating oil, winter tires or snowmachines, which are critical modes of transportation in rural villages where residents rely on hunting or trapping.

Canoy, a single mom of

two, is selling her home and downsizing. She planned to fill her home’s fuel tank as a gift to the new buyers at closing, but the fuel truck came early while she was away. So instead of putting the \$3,000 her family will receive toward other projects, as she’d hoped, she’ll use it to pay that bill. She plans to let her sons spend the remaining \$400.

Canoy said she lives comfortably and sees the dividend as a blessing. Still, she wishes lawmakers would find a better way to set the amounts — “at least to just give Alaskans maybe a little peace of mind that, yeah, we’re actually doing everything that we can to make sure that you guys get the most out of the permanent fund dividend.”

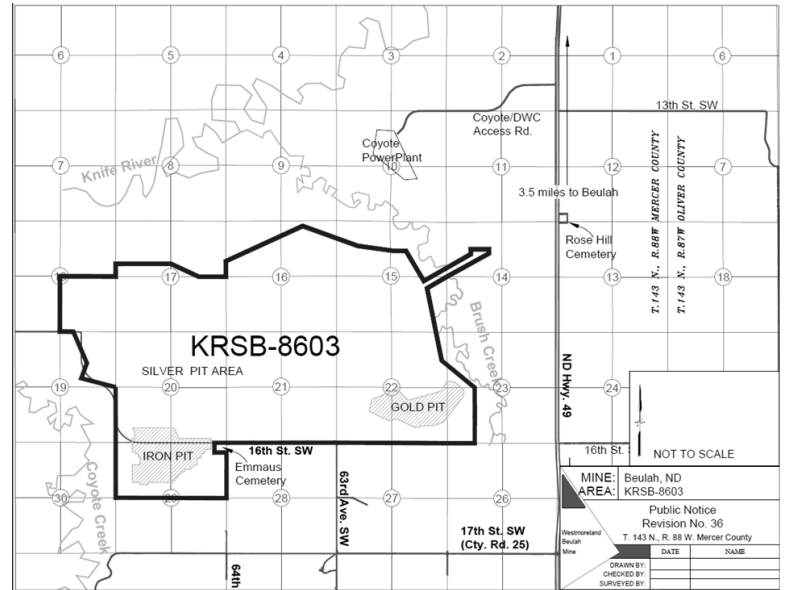
