



A **Public Hearing** on the application in Case No. PU-25-86 is scheduled for **June 30, 2025, at 9:00 a.m. Central Time at the Grand Williston Hotel & Conference Center, 3601 2nd Avenue West, Williston, ND 58801.**

On March 5, 2025, in Case No. PU-25-86, Basin Electric Power Cooperative filed an application for a certificate of site compatibility to construct a 1,490 MW combined-cycle gas turbine generator and associated facilities in Wheelock Township, Williams County, North Dakota. The location is shown on the attached map.


The issues to be considered in this proceeding are:

1. Will the location and operation of the proposed facility produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?
2. Is the proposed facility compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility location minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?




