

AFFIDAVIT OF Michael Candelaria

Michael Candelaria, being first duly sworn on oath, does hereby declare and state upon affiant's own personal knowledge as follows:

1. Affiant is an officer of Mid-Rivers Telephone Cooperative, Inc. (hereinafter, the "Company"), in the position of General Manager/CEO.
2. The Company is an eligible telecommunications carrier within the meaning of Section 214(e) of the Federal Telecommunications Act of 1996 (hereinafter, the "ACT"), and the Company is eligible to receive federal high-cost universal service support (hereinafter, the "Support") pursuant to Section 254(e) of the Act. The North Dakota Public Service Commission (hereinafter, the "NDPSC") has designated the Company as an eligible telecommunications carrier.
3. Affiant is personally familiar with all of the Support received by the Company, and with how the Company uses all of the Support that it receives.

The Company is filing this affidavit with reference to WC Docket No. 14-58 and in compliance with the order of the Federal Communication Commission (hereinafter, "FCC") dated May 23, 2001 in Docket Number 96-45 (FCC 01-157) (hereinafter, the "Order"), as codified in 47 C.F.R. §54.314 and modified by the FCC's November 18, 2011 Transformation Order FCC 11-161, which requires certification to the FCC that all federal Support will be used by carriers within each state only for the provision, maintenance, and upgrading of facilities and services for which the Support is intended, as required by Section 254(e) of the Act and 47 C.F.R. §54.7. 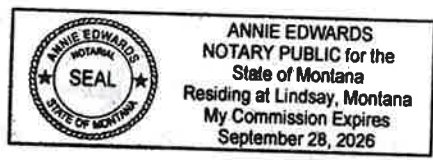
