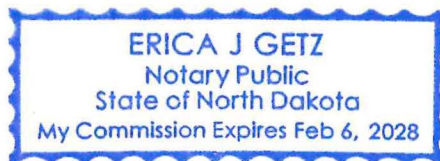

Leonardite Products LLC has filed applications to revise and renew Surface Coal Mining Permit GRGR-0501 covering lands located in:

**A portion of the W $\frac{1}{2}$  of Section 8 of T154N, R100W, Williams County containing 67.1 acres.**

The five-year permit renewal will allow Leonardite Products LLC to continue operating within the existing permit area until November 2, 2030. The revision application identifies the next five-year commercial leonardite removal subarea. The revision also updates legal information, environmental resource information, operations and reclamation plans, and the worst-case bond estimate of the permit. The revision and renewal applications and the surface coal mining and reclamation permit may be inspected at the following locations:

You may submit written comments or objections regarding the proposed permit renewal and revision applications and their effects on the environment and on surface owners of land in the permit area. You may request an informal conference with the Commission and the applicant on the renewal and revision applications. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by **August 18, 2025**.

If there is an informal conference, you may request a formal administrative hearing on the Commission's ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
