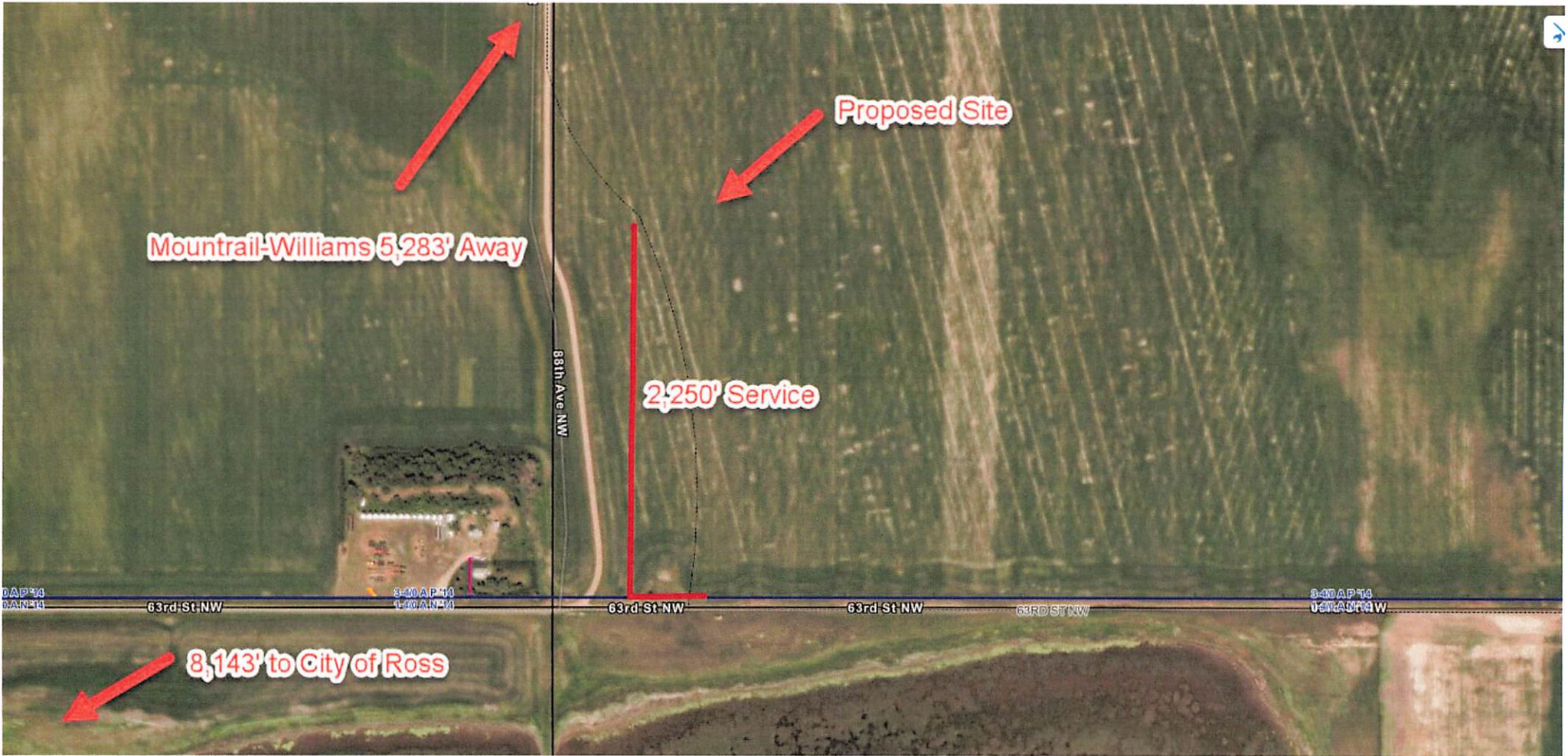
II.
