SZ falls in a pair of district matches

LADY CLIPPERS FALL TO 0-5 IN DISTRICT 2

Kidder County improved to 2-3 in District 2 with a 3-0 sweep over Strasburg-Zeeland, Sept. 25, in Strasburg. KC improved to 8-6 overall, while the Lady Clippers fell to 0-5 in District 2, and 0-12-1 overall with a loss.

KC cruised through the opening set, as the Wolves jumped out to a 5-0 lead behind the serving of Jade Shipley, and after SZ got on the board, the Wolves went on a 14-1 run to open up a 19-2 cushion. After SZ scored four unanswered points, KC ended the set with a 6-0 run for a 25-6 victory.

Back-to-back kills by Riley

Sayler and Sidney Mock gave KC the lead (9-7) for good during the second set, and after SZ closed to within 12-11, the Wolves four straight points in front of a 10-3 run, and back-to-back aces by Ava Schmidt pushed the lead to 22-14. SZ would get to within five points (24-19), but Avery Mosset's kill gave KC a 25-19 victory for a 2-0 lead in the match.

After SZ scored first in the third set, KC ripped off six straight points to move into the lead for good, and later, Maci Mittleider's ace gave the Wolves a 17-4 advantage. SZ would get no closer than 11 points after that, and KC went on to complete the sweep with a 25-7 victory.

SZ was paced by Laura

Haak (9 digs, 2 kills), Kadee Silbernagel (3 assists) and Natalie Baumgartner (2 aces, 2 assists). Jozlyn Volk added seven digs for the Lady Clippers. Individual statistics for KC were not available.

EKM sweeps Lady Clippers

Edgeley-Kulm/Montpelier improved to 4-0 in District 2 with a straight-set victory over Strasburg-Zeeland, Sept. 23, in Kulm. The Rebels improved to 13-3 overall, while SZ fell to 0-4 in District 2.

EKM yielded just 19 points in the three sets (25-6, 25-6, 25-7), and the Rebels fired 30 service aces during the match, including 11 by Betsy Huber, and six apiece from Kalyn Klusmann and Elli Lloyd. Klusmann also tallied a match-high 10 kills, while Mazie Tjernlund dished out 14 assists for the Rebels.

Laura Haak led SZ with four digs and a block, while Jozlyn

Volk and Kadee Silbernagel (service ace) added four and three digs, respectively, for the Lady Clippers.

aces and a kill by Rossow keyed a 7-0 run that gave HSA a 12-3 lead, and later, back-to-back kills by Rossow and Alyssa Kaup gave the Wolverines a seemingly comfortable, 20-7 cushion. However, LHMB began chipping away at the deficit, which would turn into a ferocious run to get back into the set.

HSA still seemed to be in good shape after Johnson's kill gave the Wolverines a 22-12 lead, but LHMB ran off six unanswered points, and Ryckman's ace trimmed the deficit to 22-18. After the Lady Lions committed an error on the next serve, Schumacher scored a kill from the back line, but LHMB hit a shot long on the ensuing serve to give HSA five set points (24-19). However, a block by Baumgartner and a kill by Schumacher kept LHMB alive, and after a timeout by HSA, the Lady Lions continued the run behind the serving of Hase.

Two more kills by Schumacher trimmed the margin to 24-23, and after an error by HSA tied the set, Schumacher belted another shot for a kill to give LHMB a match point (25-24). A kill by Rossow kept HSA alive, and then she recorded a block to give the Wolverines another set point 26-25. LHMB kept the set going on another kill by Schumacher, but HSA earned another set point (27-26) on a service er-

ror by the Lady Lions.

LHMB tied it up when Schumacher lobbed a shot into the left corner for a point, and then Bosch scored a kill off a blocker to give the Lady Lions another match point (28-27). HSA wasn't done, as Rossow tied it up with a block on the ensuing serve, and then Kaup gave the Wolverines yet another set point (29-28) with an ace. However, the Wolverines could not finish it off, and an error gave LHMB the service for good in a 29-29 deadlock.

With Schumacher at the service line, HSA hit a shot wide to give LHMB another match point (30-29), and this time the Lady Lions would finally get it done, as Schumacher fired an ace that stayed just inside the back line to close out a 31-29 victory that completed the sweep.

Schumacher finished with 19 kills, three service aces, 22 digs and a pair of blocks, while Hase netted nine kills and a dozen digs, and Madisyn Sauter tallied 31 assists, 20 digs and four kills for LHMB. Ryckman (26 digs) and Baumgartner (3 kills) each fired a pair of aces, while Bosch and Janczewski (2 blocks) added four and three kills, respectively, for the Lady Lions.

Rossow recorded matchhighs in kills (20), blocks (7) and aces (3) to go along with 22 digs, and Katie Albee dished out 41 assists and collected 26 digs for HSA. Johnson scored eight kills, and Helm chipped in 18 digs and a pair of service aces for the Wolverines.

On June 18, 2025, Emmons-Logan Energy Storage, LLC (Emmons) filed an application for a certificate of site compatibility concerning the location for a 140 megawatt battery energy storage system (Project) in Emmons County, North Dakota, as shown on the attached map. The issues to be considered in this proceeding are:

1. Will the location and operation of the proposed Project produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?

2. Is the proposed Project compatible with the environmental preservation and the efficient use of resources?

3. Will the proposed Project location minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?
