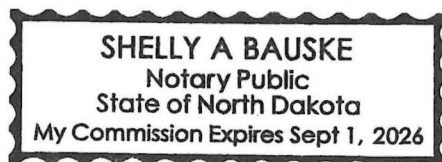

NOTICE OF RECEIPT OF REVISION APPLICATION

September 26, 2025

Westmoreland Beulah Mining LLC has filed an application for Revision No. 36 to Surface Coal Mining Permit No. KRSB-8603. Revision No. 36 proposes post-mining land use changes in the NE¼ of Section 19; post-mining topographical changes in the Iron and Gold Pit areas in Sections 20, 22, 23, and 29; and revises the reclamation timeline schedule. Revision No. 36 also updates surface ownership and corporate management lists; surface and ground water hydrology information; threatened and endangered species list; pit layout and facilities map; surface water management plan; and the revegetation plan. Coal removal activities are no longer occurring in Permit KRSB-8603. The revision application and surface coal mining and reclamation permit may be inspected at:

You may submit written comments or objections on the proposed revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for an informal conference must be made by November 17, 2025.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
