**NOTICE OF OPPORTUNITY FOR HEARING**

On September 30, 2025, Otter Tail Power Company (OTP) filed an application for an extension to the waiver granted in Case No. PU-21-416 pursuant to the terms of North Dakota Administrative Code Section 69-09-02-28(3), Meter records. The extension would continue the suspension of the existing meter testing plan and associated annual reports through 2026, to resume in 2027. The original waiver granted a suspension from 2022 through 2025.

The issue to be considered in this proceeding is whether it is appropriate to grant an extension to the waiver of the Commission's rules under North Dakota Administrative Code Section 69-09-02-28(3), Meter records.

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by December 5, 2025.** If deemed appropriate, the Commission can determine the matter without a formal hearing.
