TracFone Wireless, Inc. (TracFone) hereby notifies the Public Service Commission that it has changed its name to Verizon Value, Inc. (Verizon Value). Verizon Value is a prepaid wireless service provider that has been designated as an eligible telecommunications carrier under the company's former name.

Verizon Value's new name was registered with the North Dakota Secretary of State on April 9, 2025, as reflected in the attached documentation. The name change does not alter the company's corporate structure, management or business operations. Because the company will continue to do business as "TracFone," the branding of its stores, websites, advertising and services are unaffected by the new name. The name change thus will not impact customers. The company's principal business address remains at 9700 Northwest 112 Ave., Miami, Florida 33178.

TracFone respectfully requests that the Commission make note on its ETC designation to reflect the new name: Verizon Value, Inc.
