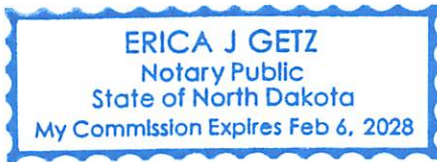

NOTICE OF OPPORTUNITY FOR HEARING

On March 31, 2026, Otter Tail Power Company filed an application requesting approval of revisions to sections of its North Dakota Electric Rate Schedule addressing clarifications, administrative efficiencies, and tariff modifications related to Special Facilities, Farm Service, the Energy Adjustment Rider, and the Real-Time Pricing tariff.

The issues to be considered in this proceeding are:

1. Are the proposed tariff revisions just and reasonable?
2. Do the proposed rates comply with the tariff?
3. Are the proposed rates just and reasonable?

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by June 10, 2026.** If deemed appropriate, the Commission can determine the matter without a formal hearing.
