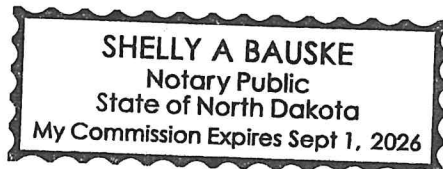

NOTICE OF OPPORTUNITY FOR HEARING

On July 10, 2013, in Case No. PU-13-22, The Commission adopted Findings of Fact, Conclusions of Law and Order issuing Certificate of Corridor Compatibility Number 142 and Route Permit Number 155, to Dakota Gasification Company (DGC), for the construction, operation, and maintenance of approximately 3.5 miles of ten-inch diameter natural gas pipeline and associated facilities in Mercer County, North Dakota.

On July 10, 2026, DGC and Basin Electric Power Cooperative (Basin) filed with the Commission a joint application to transfer Certificate of Corridor Compatibility Number 142 and Route Permit Number 155 to Basin.

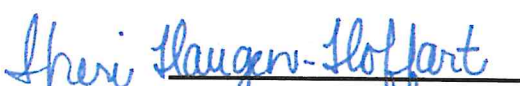
The issues to be considered in this proceeding are:

1. Whether Basin agrees and is able to comply with the terms and conditions of Certificate of Corridor Compatibility Number 142 and Route Permit Number 155?
2. Whether the requested transfer is compatible with the public interest?

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearings must be received by September 25, 2026.** If deemed appropriate, the Commission can determine the matter without a formal hearing.
