PSC to Hold Additional Public Hearings for Reconsideration of Proposed Carbon Pipeline Project

First Hearing to be Held in Mandan Starting April 22

BISMARCK, ND – The North Dakota Public Service Commission (PSC) will hold three public hearings regarding a reconsideration of a proposed carbon dioxide pipeline in North Dakota.

SCS Carbon Transport LLC (Summit Carbon Solutions) is requesting a siting permit for the Midwest Carbon Express CO₂ Pipeline Project. The project would consist of approximately 320 miles of carbon dioxide pipeline ranging from 4.5 to 24-inches in diameter and associated facilities. In addition to the pipelines, the project will include the construction of aboveground facilities that will include pump stations, pig/inspection tool launcher and receiver sites, mainline valves, and permanent and temporary access roads. The estimated cost of the project is \$898 million.

The proposed pipeline would be built in parts of Burleigh, Cass, Dickey, Emmons, Logan, McIntosh, Morton, Oliver, Richland and Sargent Counties.

***This hearing will focus primarily on the adjustments in Emmons, Logan and McIntosh Counties.**

The hearings provide an opportunity for members of the public to contribute to the PSC's official record. Any comments from members of the public must be received at a hearing to be part of the record. People with concerns, questions or support/opposition for the project are encouraged to attend a hearing and present their information. Information received after the hearings will not be part of the official record and cannot be used as a basis for the Commission's decision unless certain additional procedures are followed.

The North Dakota Public Service Commission is a constitutionally created state agency with authority to permit, site and regulate certain business activities in the state including electric and gas utilities, telecommunications companies, power plants, electric transmission lines, pipelines, railroads, commercial weighing devices, pipeline safety and coal mine reclamation.
