Emergency Information

Medical/Fire Emergency:

- Call 911

Threatening Individuals & Routine Law Enforcement Matters:

- Notify **Highway Patrol** at **328-9963**.
- After normal working hours call 328-2464 (capitol security).

Bomb Threat:

- Get as much information as possible from caller (use the Bomb Threat Report form, SFN 51502—previously provided to staff—or contact an emergency coordinator for a copy).
- Do not hang up the phone—keep line open to assist with tracing efforts.
- Go to another phone and call 911.

Evacuations:

- **Fire**—Unless otherwise advised, both 12th and 13th floor personnel use the **south stairway** to evacuate the building. **Exit** the building **via** the front doors and the visitor entrance to the **large ND flowerbed** area on the **south side** of the building.
- **Weather**—Unless otherwise advised, use **south stairway** to evacuate to the **Ground Floor**. Go to “safe” area in the **hallway between the elevators and the cafeteria**.
